## **Statement on Conflict Minerals**

April 2025

Kano Laboratories LLC takes concerns that profits from metals mining ("conflict materials") may be fueling human rights atrocities in the Eastern Region of the Democratic Republic of the Congo (DRC) very seriously.

The U.S. Securities and Exchange Commission (SEC) implemented a new set of regulations related to "conflict minerals", as Section 1502 of the Dodd-Frank Wall Street Reform and Consumer Protection Act (Wall Street Reform Act) in 2010. The legislation required companies like Kano Laboratories LLC to disclose whether products were produced with conflict minerals sourced from the Democratic Republic of the Congo (DRC) or adjoining countries to the Securities and Exchange Commission (SEC). The legislation applied to tin, tantalum, tungsten and gold, also known as 3TG, and also to derivatives of cassiterite, wolframite, and columbite-tantalite.

Kano Laboratories LLC is compliant with this act and other regulations concerning the sourcing of our raw materials from conflict areas, and we use suppliers who comply with the regulations as well.
